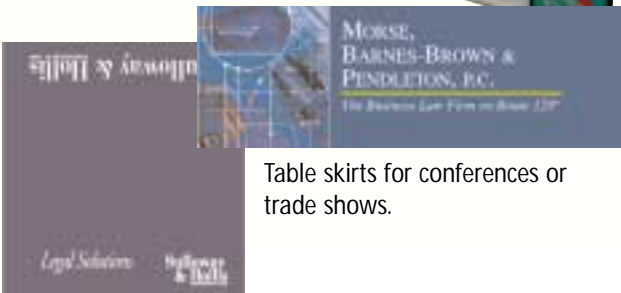

Businesses need to promote themselves to be successful. We have been involved on many new design projects over the last several months. A couple that we had a lot of fun working on were these portable trade show booths and table skirts for conferences.

(left, top) Dental Replacements Inc., a dental employment agency, called on us to design their conference booth, web site and agency brochure. We were able to bring a consistent look to their marketing materials for their yearly trade show by doing all of the projects at the same time.

(left, below) For the Sea Crest Resort and Conference Center we designed a 10' booth to promote their conference facilities. We used the Display ONE Exhibit System which lets them use the entire setup for a large gathering or just one of the panels for a smaller meeting. This gives them 4 setups for the price of one.

(bottom) A couple of table skirts for two law firms. The Sulloway & Hollis table banner allows them to have two different looks for one price by just flipping it around. The Morse, Barnes banner is affixed to the front of a table by velcro. Banners can be printed on fabric or vinyl with unlimited number of colors

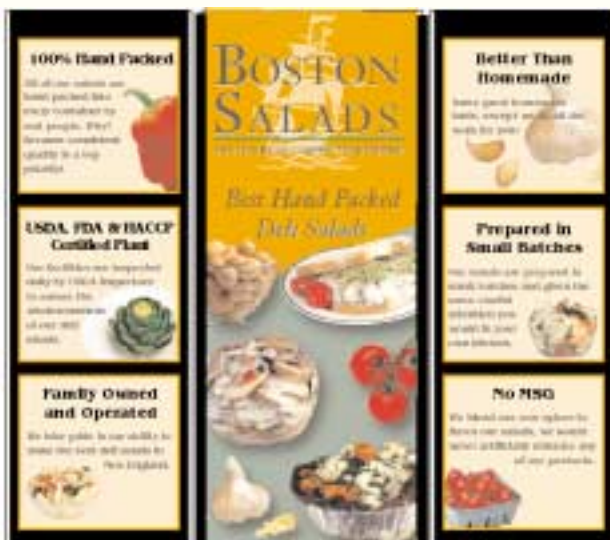
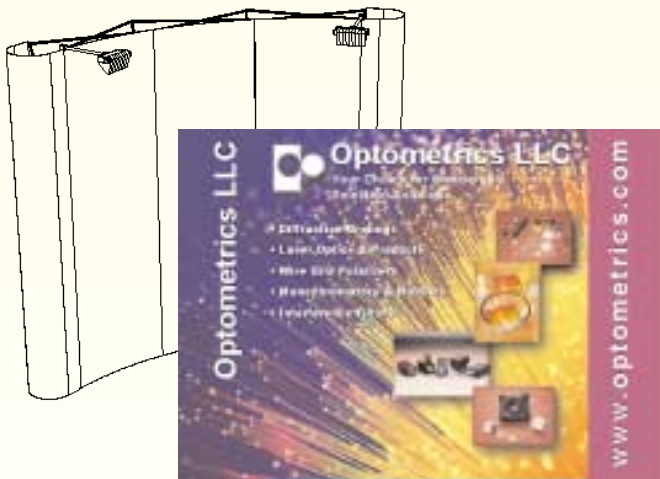

Table Top Units

Table top portable display setups for 2 New England Law firms. Both of these used the Display ONE Exhibit System.

The Goulston & Storrs table top booth used a repeat of their logo on the outside for a simple but effective presentation. This booth used printed vinyl panels. The Sulloway booth was printed on Lambda photographic panels that were then mounted on Velcro backing. Both of these booths can be easily updated for different presentations.

The Sulloway & Hollis unit was also combined with a table banner to complete their presentation. This banner was set up with different logos that allowed them to have two different looks for one price by just flipping it around. Banners can be printed on fabric or vinyl with unlimited number of colors.
